4. The school shall comply with the provisions of Rules 176, 177, 18(5), 17(3) & order dated 15.12.1999, 10.05.2005, 11.02.2009, 16.04.2010 19.02.2016 dealing with the regulation of fee along with the subsequent orders issued by DoE from time to time.
5. The school shall comply with the order dated 07.11.2011/guidelines of DoE and judicial pronouncements w.r.t. safety & security of the school children and take all steps in this regard.
6. Compliance of other conditions as mentioned in provisional recognition/provisional up-gradation granted to the school.
7. The Manager of the School shall be replaced within 06 months with another Manager, having eligibility as per Circular of DoE dated 24.11.2004.
